There will be a 15% administrative fee for cancellations made on or prior to May 31. This fee applies to transfers to another open session as well as refunds. There will be a 30% administrative fee for cancellations made on or after June 1. This fee applies to transfers to another open session as well as refunds as long as it is more than 2 weeks prior to the start date of your camp session. There will be no refunds or transfers given within two weeks of the start of the camp session.

HAWS Members are entitled to a 12% discount off camp registration. Anyone who adopted an animal from HAWS (701 Northview Road in Waukesha) within the last year is a member (this does not apply to adoptions from other organizations).

Memberships can also be obtained by joining and paying a membership fee and can be obtained for as little as \$25.00 per year. The camper does not need to be a member as long as membership is held by a parent or the adult that is paying for camp registration. You do not have to provide proof of membership. HAWS will check membership status upon receipt of your camp registration.
